Mr. Max Kubierschky (date of birth: 08 January 1967) was employed as a mathematician and software engineer with us from 08 March 2010 to 29 March 2012. He had previously worked for our company from February 2008 as a freelancer.

The services z-optimations provides are aimed at reducing the mechanical non-productive time of machines controlled by CNC and PLC.

Mr. Kubierschky developed and implemented complex mathematical algorithms in the field of motion optimisation.

His duties included the following:

- developing modules with which to calculate the optimum speed profile for a given path; the modules also served to find the best possible path, and to avoid any obstacles along this path. In developing the modules, Mr. Kubierschky needed to take various kinematic constraints into consideration, e.g. limits on speed, acceleration and jerk function.
- developing modules with which to calculate spline fits for the approximation of predetermined movements by means of polynomials in several dimensions. These modules were also used to calculate suitable supporting points for the spline fits, taking into account a given maximum deviation.

- contributing work towards our in-house optimisation tool in the following areas: parsing a customer's CNC code for the Siemens 840D control system; simulating the resulting movements; an interactive, three-dimensional graphical representation of the movements.
- analysing the potential for optimisation of flank processing by examining the customer's CNC code and the measured data of machine movements.
- developing a logging tool to record machine events in a compressed manner and make them accessible. The most important aspects of this work were great resilience against external disruption, and fast data access.

Development was carried out under Delphi and in CNC code.

The tasks were characterised by code development that placed high demands on reliability and general validity. Mr. Kubierschky created suitable unit tests, defined the interfaces clearly and also prepared excellent documentation.

Mr. Kubierschky always fulfilled the tasks he was assigned to our complete satisfaction. The software developed by him is of remarkably high quality. Mr. Kubierschky was also invariably able to come to grips with difficult problems in a quick and independent manner. Since he possesses broad, and especially profound, expert knowledge and came up with many creative ideas, his results were always well above the average. His work made a significant contribution towards the success of our company.
